The Malaysian Private Entities Reporting Standard (MPERS) issued by the MASB replaces the existing Private Entity Reporting Standards (PERS) effective for financial statements with annual periods beginning on or after January 1, 2016.

Late last year, the MASB issued the 2015 Amendments to the MPERS, which is effective for financial statements with annual periods beginning on or after January 1, 2017, with permission for earlier application.

So where shall private entities go from here? Are you really ready?
